Regulations of the Council of Engineers
On Issuance of License for Practicing the Regulated Engineering Profession at the Level of Adjunct Engineer (No. 2),

B.E. 2555 (A.D. 2012)

Whereas it is expedient to revise the Regulations of the Council of Engineers on Issuance of License for Practicing the Regulated Engineering Profession at the Level of Adjunct Engineer;

By virtue of Section 8 (6) (d) and (f) and paragraph two of Section 46 of the Engineer Act, B.E. 2542 (A.D. 1999), which is a law containing certain provisions relating to the restriction of rights and liberties of persons, for which Section 29 in conjunction with Section 42 and Section 45 of the Constitution of the Kingdom of Thailand so permitted by virtue of the provisions of law, the Council of Engineers by the resolution of the Ordinary General Assembly of the Council of Engineers and approval of the Special President of the Council of Engineers issues these Regulations as follows:

- Clause 1. These Regulations shall be called "Regulations of the Council of Engineers on Issuance of License for Practicing the Regulated Engineering Profession at the Level of Adjunct Engineer (No. 2), B.E. 2555 (A.D. 2012)."
- Clause 2. These Regulations shall come into force from the day following the date of its publication in the Government Gazette onwards.
- Clause 3. The provision of Clause 8 of the Regulations of the Council of Engineers on Issuance of License for Practicing the Regulated Engineering Profession at the Level of Adjunct Engineer, B.E. 2543 (A.D. 2000), shall be repealed and replaced by the following:
- "Clause 8. An applicant for license of the adjunct engineer level shall have passed the academic test to practice the regulated engineering profession in accordance with regulations issued by the Council of Engineers."
- Clause 4. The provision of Clause 9 of the Regulations of the Board of the Council of Engineers on Issuance of License for Practicing the Regulated Engineering Profession at the Level of Adjunct Engineer, B.E. 2543 (A.D. 2000), shall be repealed and replaced by the following:
- "Clause 9. An applicant for license of the adjunct engineer level who has passed the academic test under Clause 8 shall pass the training and academic test in relation to provision of readiness to practice the regulated engineering profession in accordance with regulations issued by the Council of Engineers.

The provision of paragraph one shall not apply to those who have already passed the training and academic test in relation to provision of readiness to practice the regulated engineering profession."

- Clause 5. The provision of Clause 10 of the Regulations of the Board of the Council of Engineers on Issuance of License for Practicing the Regulated Engineering Profession at the Level of Adjunct Engineer, B.E. 2543 (A.D. 2000), shall be repealed and replaced by the following:
- "Clause 10. For a person granted with a license to practice the regulated engineering profession of the adjunct license level under the Regulated Engineering Profession Act, B.E. 2505 (A.D. 1962), if he/she wishes to practice the regulated engineering profession in another type of work, he/she shall proceed to apply for the license to practice the regulated engineering profession of the

adjunct engineer level under the Engineer Act, B.E. 2542 (A.D. 1999), and successfully pass the test and training under Clause 8 and Clause 9."

Clause 6. Rules of the Council of Engineers on Practical Academic Test for the Adjunct Engineer Level, B.E. 2544 (A.D. 2001), until the Rules under Clause 8 of the Regulations of the Council of Engineers on Issuance of License for Practicing the Regulated Engineering Profession at the Level of Adjunct Engineer, B.E. 2543 (A.D. 2000), as amended by these Regulations is issued.
